



Boatlift Only - Commercial Permit Guidelines

(may include pilings)

CGC, CBC, CRC or Owner Builder may apply for permit

- Marine Improvement application.
- Four (4) copies of dock showing location of lift
- Four (4) copies of boatlift engineering (specs)
- One (1) copy of notarized hold harmless letter if used lift is being installed (in lieu of lift specs) **to state not alterations made to lift and will not hold City responsible for any damage caused by lift.** Note hold harmless letter received in inspection area.
- Four (4) copies of site plan indicating dock/lift projection and setback dimensions
- Owl Affidavit
- Owner/Builder Affidavit (if homeowner).
- NOC if value is \$2500 or greater.
- One (1) copy of DEP approval (if applicable, not required for freshwater)
- **In the case of a Condominium, if the docks are owned by the Condo Association a licensed contractor must apply for the permit. The deed hold for a Condo can only apply as owner builder if the dock is also included in the deed.**

Description:

- Name of Business or Condo name, slip #, Size of boat lift and whether it is new or used.

Fees:

- Boat lifts Commercial \$220.00
- Fire Fees (\$7.85/\$1000 or \$40 min)
- Surcharge NO

Expiration:

- Six (6) months

NOTES:

Separate Electric permit required to be issued prior to Boatlift/Wood Dk/Pilings (071) inspection.

This city issued permit **IS NOT** APPROVAL TO START CONSTRUCTION; YOU MUST OBTAIN APPROVAL FROM THE CORPS OF ENGINEERS.
